Consistory Meeting Minutes - August 20, 2009

- **I.** <u>Call To Order/Roll Call:</u> Meeting was opened by Lynne Stewart, Vice President at 6:36 P.M. Candle was lit and prayer was offered by Jim Rinehimer. - **II.** <u>Secretary's Report:</u> Minutes from July 16th meeting were given to some members via email. The remaining members received a copy prior to meeting. - 1. <u>New Fundraiser Ideas:</u> Krispy Kreme Donut Sale?? Would need to sell at least 100 dozen to get refunded price. Would be too difficult especially with holidays approaching. Discussed having another hoagie sale. Will get sheets out and begin selling on Sun. Aug. 23rd and make cut off date on Sun. Sept 13th. Will set up on Fri. evening and assemble on Sat. morning (Sept. 19th).
- 2. <u>Dumpster Use</u>: Jim purchased a masterlock for dumpster & chain is already assembled. Keys have been made up & will be located in both janitor's closet & on bulletin board in kitchen.
- 3. Sink Sprayer For Kitchen: Purchased & installed already by Steve Moyer. Thanks Steve!!
- 4. <u>Repair of Pastor's Laptop Computer:</u> Finished! Thanks to Dustin Harter for repairing Pastor's computer! It only cost \$25.00 as opposed to \$300.00 quoted from Dell.
- 5. <u>Holy Humor Sunday:</u> Pastor Penny's sister 'Sparkles' was very well liked as a leading part of Sun. July 19th service. Good comments on service! Everyone seemed to enjoy it!!
- 6. <u>Benevolence Distributions:</u> Denise will be checking with Debbie to see if we can send one or two of the offerings since we have been doing well with the fundraisers.
- 7. <u>Pictorial Directory:</u> Denise reported that her daughter, Glynis, has been working on several of the activities pages & has a list of pictures still needed. Denise will forward them to Sharon Moyer & see when she can take needed pictures. Will meet as a committee again soon.

V. New Business:

1. <u>Safe Deposit Box:</u> Currently have a safe deposit box at Citizen's Bank which costs \$38.00 per year. Needed it in past to keep important papers such as Certificates of Deposit, mortgage & incorporation documents. We now have a fireproof safe & can store these documents in this box and stop rental of safe deposit box. The banks do not issue CD's on paper anymore & only give a statement indicating that we own one & telling us when one is up for renewal. Discussion of

2. Office Equipment:

- a. *Color Computer Printer*: Printer in Pastor's office is not working & review of error code indicates that it can not be repaired. Would like to purchase a new color printer/fax/copier which will cost between \$200 to \$300.00 Would be useful in printing color bulletins for special occasions such as Christmas, Easter, weddings, etc. Discussion. Decided to allow Pastor research & choose printer that she feels would be best. Money will come out of Memorial Fund. Motion made by R. Rinehimer & seconded by J. Rinehimer. Motion carried.
- b. *Answering Machine:* Current answering machine is also fax machine. If we purchase color computer printer then fax machine will come with that. Need to bring phone system into the 21st century. Will cost about \$20-\$25 a month to have DSL instead of dial-up. One phone line instead of two (Two would be additional \$40 a month). Will not need to buy answering machine. Will have DSL service with voicemail, caller ID and call forwarding. Currently have dial-up & is very very slow. Money to come from Memorial Fund. Motion made by J. Rinehimer & seconded by C. Dietrich. Motion carried.
- c. *Chair for Secretaries Desk:* Current chair is very old & not comfortable at all especially when working for longer periods of time. Recently received a "Staples Rewards" for about \$40. Will use that toward purchase of a new chair. Discussion. Will tell Denise to purchase a new chair up to \$100.00 & can also use rewards too. Money to come from Memorial Fund. Motion made by H. Eigenbrod & seconded by D. Myers. Motion carried.

Called Consistory Meeting - Sept. 6, 2009
